### 4. FIRST AID MEASURES

### First aid measures

If symptoms persist, call a physician. General advice

Eye contact Flush immediately with plenty of water for 15 minutes. Lift upper and lower eyelids for

complete rinsing. If irritation persists after rinsing, get medical attention.

**Skin Contact** Flush with water for 15 minutes. If irritation persists after rinsing, get medical attention.

Inhalation Remove victim from immediate source of exposure to fresh air. If breathing is difficult.

### 5. FIRE-FIGHTING MEASURES

#### Suitable extinguishing media

Water spray (fog). Dry chemical. Carbon dioxide (CO2). Alcohol resistant foam.

Unsuitable extinguishing media Avoid using a direct stream of water.

Specific hazards arising from the chemical Flammable. Vapors can travel to a source of ignition and flash back. Empty containers retain product residue (liquid and/or vapor) and can be dangerous. DO NOT pressurize, cut, weld, braze, solder, drill, grind, or expose such containers to heat, flame, sparks, static electricity, or other sources of ignition.
