4. FIRST AID MEASURES

First aid measures

General advice Immediate medical attention is required.

Eye contact Flush immediately with water for 15 minutes. Lift upper and lower eyelids for complete

Most important symptoms and effects, both acute and delayed

Symptoms Corrosive. Causes tissue destruction, permanent damage to the cornea, blindness.

Causes irritation (possibly severe), burns to the skin. Mists may cause lung irritation, shortness of breath, fluid in lungs. Ingestion causes nausea, vomiting, diarrhea, corrosion, burns to mouth and esophagus, abdominal pain, chest pain, shortness of breath, seizures,

death.

Indication of any immediate medical attention and special treatment needed

Note to physicians Product is a corrosive material. Use of gastric lavage or emesis is contraindicated.

Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood

pressure may occur with moist rales, frothy sputum, and high pulse pressure.

Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incinerate, or, if allowed by State and local authorities, burn container. If burned, stay out of smoke.
