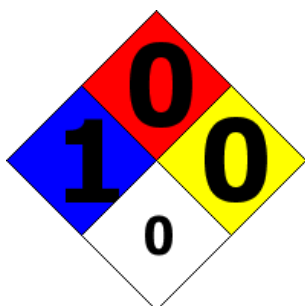

Description of first aid measures

SECTION 7 : Handling and storage

Precautions for safe handling:
